Abstract:	The Rotheus Hayward Collection consists of papers related to the Hayward family of Waterford Township, Washington County, Ohio. The correspondence and diaries of family members document the evolution of Ohio farm life from the time of early statehood through the Civil War.

Biography/History

The oldest son of Joseph Hayward and Lydia (Barrows) Hayward, Rotheus Hayward was born October 14, 1781, in Easton, Massachusetts. In the fall of 1805, he emigrated west to Marietta, Ohio, where he worked in the shipyard of Edward Tupper. The following year he purchased a 105-acre farm above the mouth of Wolf Creek, near Waterford, Washington County, Ohio.

On January 29, 1807, Rotheus Hayward was married to Panthea Nye, daughter of Ichabod Nye and Minerva (Tupper) Nye. The couple had seven children: Joseph; Benjamin Tupper; Rotheus; Ichabod; Lydia; Edward; and George. Panthea (Nye) Tupper died January 24, 1821, and on March 18, 1822, Rotheus married Rebecca Gray, daughter of William Gray and Mary (Diamond) Gray. Five more children were added born: Charlotte; Panthea; Daniel; Columbus; and Cyrus.

A captain in the militia and a township trustee, Rotheus Hayward was a farmer and stock raiser by occupation. During the course of his lifetime, he added to his land holdings until he accumulated a property of 500 acres. Rotheus died May 22, 1842, and Rebecca died September 28, 1876.

Scope and Content

The collection contains correspondence dating from 1804 through 1945, with most of it covering the years 1804 to 1865. The letters of Rotheus Hayward begin when the 23-year-old leaves home in 1804 in search of an occupation. Letters to his family contain descriptions of people

and places, as well as detailed accounts of his activities in farming and raising a family in Waterford, Washington County, Ohio. The letters written by his family in New England are filled with advice and news from home. Edward T. Hayward, a Rotheus' brother, also settled in the Waterford area, and several of his letters are part of the collection. Also included are a few letters written by the Tupper and Nye relatives, regarding both business and family issues. A small amount of correspondence during the 1860s relates to family and friends who are serving in the Civil War, and most of the papers from 1883 to 1945 are connected to Hayward family members who moved to Oregon.

An important part of the collection is the diaries of Rotheus Hayward, Jr. (1811-1885), dating from 1835 until 1842, and containing brief daily entries describing life on the Waterford farm, social events, and his work at the iron foundry in Marietta. Of special interest are his accounts of boat trips, taking produce down the Ohio River, in 1836 and 1837.

In addition to correspondence and diaries, there are a small number of deeds, business receipts, legal papers, genealogical materials, and books, including two bibles.

Transcriptions of the diaries and most correspondence are available.

Statement of Arrangement

Dated correspondence and papers are arranged in chronological order in Boxes 1 and 2, followed by miscellaneous undated materials. The diaries of Rotheus Hayward, Jr., can be found in Box 3, and are also arranged in chronological order, with some extra entries placed at the end. Books are kept together in Boxes 4 and 5.

Box 1/Folder 1: 1804-1805

1. Rotheus Hayward letter to "Dear Parents," describing his trip from Easton to Winthrop. Winthrop, Maine, May 8, 1804.
2. Joseph Hayward letter to son, Rotheus Hayward, providing advice. Easton, June 2, 1804.
3. Rotheus Hayward letter to "Dear Brother," about their father coming to "Kennybec." Augusta, August 23, 1804.
4. Joseph Hayward deed to Rotheus Hayward, for land in the Ohio Company Purchase, Range 12, Township 4. Easton, County of Bristol, Massachusetts, September 27, 1805.
5. Joseph Hayward letter to Rotheus Hayward, telling of recent sickness in the community. Easton, November 28, 1805.
6. Rotheus Hayward letter to "Respected Parents." News of his arrival in Marietta and work for Mr. E. W. Tupper, who "has been engaged in building his vessels." Marietta, December 7, 1805.

Box 1/Folder 2: 1806

Rotheus Hayward letter to his parents, saying that he receives one dollar per day working in the shipyard, and that Tupper "has received news of the sail [*sic*] of his brig which was made for \$6,500 – it is generally supposed that he will do very well with the vessels he is now building for the United States." Marietta, January 19, 1806.
2. Rotheus Hayward letter to his parents, containing news of people in Marietta. Marietta, April 6, 1806.
3. William Skinner, Sheriff for Washington County, deed to Edward White Tupper. Tract of land was "mortgaged to Mary Gleason of said Marietta widow, to satisfy two judgments which the said Gleason lately recovered against the said McClure . . ." The land consisted of 105 acres on the Muskingum River, a little above the mouth of Wolf Creek. Marietta, May 1, 1806.
4. Edward White Tupper deed to Rotheus Hayward for 105 acres of land near the mouth of Wolf Creek in the township of Waterford. Marietta, May 1, 1806.
5. Edward W. Tupper letter to his uncle, Joseph Hayward, regarding a farm he sold to Rotheus and the payment for it. Wrote "to Unkle Solomon on the subject of letting his little son Solomon come out to live with me. . ." Marietta, May 3, 1806.
6. Rotheus Hayward letter to his parents, describing the new farm he purchased "in the town of Waterford on the West bank of the Muskingum River." Asks for money to help pay for the farm and stock it. Waterford, May 22, 1806.
7. Rotheus Hayward letter to his parents, regarding his farming operations and reminding them that he needs money. Waterford, July 25, 1806.
8. Joseph Hayward letter to Rotheus Hayward, telling of his attempts to meet with Gen. Tupper to give him money. Pomfret, Connecticut, August 18, 1806.
9. Joseph Hayward, Jr., letter to his brother Rotheus Hayward. "Mr. Gilmore writes you are about to get married i hope you will Get you likely woman." Easton, September 10, 1806.

6. Receipt stating all accounts and notes had been settled, signed by Rotheus Hayward and Benjamin Nott. Waterford, February 16, 1809.
7. Benjamin Tupper letter to Rotheus Hayward, regarding “a Girl in your neighbourhood who would hire out at 75 cents pr week.” Mentions illness of “little Sophia.” Springfield, September 23, 1809.

8. David Gilmore letter to Rotheus Hayward, regarding a judgment against Robert Oliver. March 4, 1813.
9. Elisha Hayward, Joseph Hayward, and Lydia Hayward letters to Rotheus Hayward, informing him of the death of “Grandma Bassett” and other family news; discussion of the war. Easton, May 7 and 8, 1813.
10. Rotheus Hayward letter to his parents, describing the weather and a flood, and discussing the war. “In these parts our war men begin to be almost sick of the war they find Canada not to be so easily subdued as they supposed it might be.” Waterford, August 9, 1813.

7. Rotheus Hayward letter to his father, Joseph Hayward, announcing the death of his son, Ichabod Nye Hayward. "We have late had something of a revival of religeon amongst us . . ." Waterford, October 9, 1815.
8. Timothy Buell, Collector, receipt for \$6.20 from Rotheus Hayward for taxes. November 7, 1815.
9. Timothy Gates deed to Thomas Black, "house write," for 18 acres of land in Range 10, Township 5, Waterford. December 23, 1815.
10. Elisha Hayward letter to his brother, Rotheus Hayward, with neighborhood news and the message that "Father is almost ready to make you a visit." Easton, September 7, 1816.
11. Joseph Hayward letter to his son, Rotheus Hayward and Panthea Nye Hayward, describing his return home from Marietta. Easton, December 20, 1816.

6. Arius and Rowena Nye letter to Rotheus Hayward, informing him of the death of their son, Benjamin Tupper Nye and announcing that he has been admitted to practice as an attorney at law. Acknowledge "the very acceptable present of boild cider & apples." Putnam, November 11, 1818.
7. Rotheus Hayward letter to his parents, announcing the birth of his son, Edward Nye Hayward; complains about Gen. Tupper and the deed for land. Waterford, February 16, 1819.
8. Horace Nye letter to his brother-in-law, Rotheus Hayward, discussing how to obtain nails and glass. Putnam, March 26, 1819.
9. Elisha Hayward and Lydia Hayward letters to Rotheus Hayward, telling of the illness and death of his sister. Easton, July 14, 1819.
10. Elisha Hayward letter to Rotheus Hayward, containing news of family and neighborhood. Randolph, September 17, 1819.

Also recommends that Sacket Reynolds replace Mr. Tyler at the land office at Crawfordsville, Indiana, and that Thomas B. Riley replace Reynolds; John Wilson to replace Riley.
